#### A description of how the development of the plan was influenced by community input.

Students, staff and parents were all concerned about the quality of air and ventilation in the kindergarten classroom. The HVAC system is 28 years old and does not work properly or consistently blow air. In order to keep students safe for in person learning the Meridian school community agrees that an HVAC system is of the utmost importance.

Members of the school community were also concerned with learning loss. Staff, parents, and students all agreed that offering an afterschool program and alternating and extending the bussing would provide students an opportunity for learning recovery.

Before writing this plan, the community was consulted through various means. Our school is very small with only 12 staff members and around 50 families. It is very easy to have many personal conversations throughout the year. Many conversations took place about addressing Covid 19 and learning loss as we developed the 2021-2024 LCAP. In addition, we sent home surveys and letters soliciting feedback. Older students were asked for their input directly.

Many students and parents were excited about the prospect of an afterschool program to help address learning loss. A stipend for the afterschool program is included in the LCAP, however, there is a need for snacks for the students and materials necessary for providing a robust program.

In looking at our most recent CAASPP scores, the school board, administration, parents, and teachers were concerned with our progress in math. We determined that we needed a more robust online math program to help address learning loss that could be individualized for

students specific learning needs. Parents, students, the school board, and staff all agreed that a program would be beneficial to help address learning loss.

In meeting with the director of the Sutter County Selpa, she agreed that our idea for I-Ready math intervention, materials for an afterschool program, and a new working HVAC system were all good ideas to serve our school.

Family Soup was concerned about student behavior and student anxiety. Probation has noticed an increase in the number of referrals based on students acting out. Behavioral health identified an increase in triage for anxiety about returning to in-person schooling. Children and Families commission are also seeing behavioral issues and anxiety in their age group. The community partners were supportive of plans that included incentives for creating a positive school environment. This is not addressed in our Esser III plan because we have already addressed this with LCAP money.

Other suggestions from community partners was working on classroom ventilation and filtration. Eighty percent of our Esser III plan goes toward the replacement of our kindergarten HVAC system which does not ventilate and filtrate properly.

Community partners were supporting of providing more SEL supports. Our LCAP addresses counseling services and SEL curriculum for our school.

Community partners suggested using funds for technology that will provide devices and connectivity at home. Meridian is already at a 1 to 1 ratio for devices. We are a country school and even with hotspots, connectivity isn't always possible. We will be purchasing 56 new chrome books with our ELO money and the old chromebooks will go home with students who have access to the internet. Therefore, this is not necessary with Esser money.

Another suggestion that our community partners had was academic diagnostic and benchmark assessments. We used our LCAP money to purchase I-ready math and reading. However, we felt that our students would benefit from purchasing the digital math intervention through I-ready and hope to use ESSER III funds for this purchase.

Afterschool Tutoring Program	Students enrolled in the afterschool program will receive daily homework help and intervention for reading and math skills. Progress will be monitored through district benchmarks, grades, and state testing. Not only will this provide support for academic needs, it should improve the social and emotional health of students as it provides an additional opportunity for positive interaction with their peers. Social emotional progress is difficult to monitor, but can be observed through the interactions of students and their positive engagement in class and the after school program.	Students will be given district benchmark assessments three times a year. Progress Reports come out every six weeks. Report cards are given every trimester and state testing is given yearly. The school counselor and teachers will be consulted at the end of each trimester in order to assess how the afterschool program is benefiting students social emotional health.
I-Ready Math Program	Students will be given time daily to work on the I-Ready math program. Teachers are able to access and monitor student progress through the online program. In addition, three diagnostic assessments will be given to all students throughout the year to monitor progress. Teachers will be provided training through I-Ready for how to administer the assessments, how to run the program, and how to analyze the data.	Students will be given I-Ready Math assessments every 15-18 weeks in order to make sure that students are progressing in their math skills and reaching the California state standards. Students will be given an initial diagnostic at the beginning of the school year, another one in January, and another one in May.
