School Facility Conditions and Planned Improvements

Our most recently collected FIT data is a rating of good, 95.5%. Our facilities are in good condition. The LEA takes great effort to make sure the school is clean, safe, and in good repair for the students that we serve. We have sufficient classrooms to meet students needs, including a cafeteria, library, a large area for outdoor play and physical education. Our outdoor area includes a swing set, a play structure, basketball courts, a volleyball court, football field, soccer field, and a baseball diamond. We are planning improvements in the cafeteria, the roofing, and the HVAC systems in the next few years. In addition, this year we replaced an HVAC system, replaced an outdoor gas line, and are currently working on replacing outside classroom doors.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. We discussed the School Safety Plan in a staff meeting in August of 2022. I solicited input from the staff as well as a student representative in January of 2023. The school plan is comprehensive.
